Federal Requirements and Deadlines

> Respond to Completers List with corrections within 60 days of initial draft

> Prior to October 01, 2024, determine which Student Level Reporting cohort option your school will lock in (either Standard *or* Transitional cohort)

> By October 01, 2024, schools must submit Student Level Reporting and Program Level Reporting
